User agrees to release and indemnify Willamette Pass and its employees and agents from any and all claims and liabilities (including claims based upon negligence) arising out of or in connection with the use of the ski area facilities, skiing, snowboarding and ski races of Willamette Pass. User assumes all responsibility and liability for the selection of personal equipment (including helmets).
